The Arts Alive! Visual and performing arts festival is celebrating its 20th year in downtown Quakertown, Bucks County, Pennsylvania.

Deadline

The deadline for all applications is July 10, 2020. Early applications guarantee that your product will receive maximum exposure.

Application process and fees

There is NO fee for your 12 X 12 space, which does require you to offer free samples for the whole day of event. If you wish to have two spaces your fee will be \$75.00 for the extra space. If you require 120 volt electric service it is available for an additional \$15.00 fee. Checks should be made out to Quakertown Alive!. There is a \$25.00 fee for returned checks due to insufficient funds. You may sell your products by drink, bottle or can.

All applications are subject to committee approval.

Refund policy/Rain Plans

The rain date is Saturday, July 25, 2020 from 10 am to 4 pm. If the vendor decides to cancel and does not attend the rain date, even if due to bad weather, the vendor will not receive a refund.

In the event both dates need to be canceled by Quakertown Alive! due to weather, we will refund half the vendor fees upon request by letter and a self addressed stamped envelope within 30 days. Any monies not requested to be refunded will be considered a donation to the programs of Quakertown Alive!, a 501 3 (c) non-profit organization.

ALL VENDORS MUST BE IN THEIR DESIGNATED SPACE(S) BY 9:30AM ON THE DAY OF THE EVENT.

All trailers/set-ups must be kept clean. Vendors should provide at least one trash receptacle for customers' refuse.

All Vineyard/Beer Garden vendors will have a donation collection jar, provided by Quakertown Alive!, at their locations. These donations are to support our Quakertown K-9 unit.
