Quakertown Alive! is celebrating over 25 years in downtown Quakertown and invites food vendors to submit the attached application to participate in this event. Applications will be reviewed in a timely manner by a representative of the Events Committee. Applications will not be considered for the event unless all required forms and payment are submitted. Please keep in mind that there is limited space for the Food Court and completed applications are considered as they are received. It is first come, first served to hold a spot in our food court. Accepted vendors will receive confirmation emails.

**All vendors must agree to the attached VENDOR TERMS AND CONDITIONS. This application will not be considered complete without the signed agreement on the last page.**

Our rain date is Sunday, May 18 from 10am to 4pm. If you cancel and do not attend the rain date, you **will not** receive a refund. In the event that both dates need to be canceled by Quakertown Alive!, we will refund half the vendor fees upon request by letter with a self-addressed stamped envelope within 30 days. Any monies not requested to be refunded will be considered a donation to the programs of Quakertown Alive!, a 501 (c) 3 non-profit organization.

There is a \$25 fee for returned checks due to insufficient funds. If your application is accepted, your entry fee will be processed, otherwise your check will be returned to you. **Only one vendor is permitted per space.**

***Due to the space needed to maneuver larger vehicles into place, we require ALL of our food truck vendors to begin entering at 7:30 am and you MUST be parked by 9:00 am. It is CRUCIAL to arrive on time due to safety and traffic reasons. If you do not arrive by 9:00 am, it will be up to the discretion of Quakertown Alive! to determine if you may still be admitted. There will be NO refund if vendor is late. You will***

Quakertown Alive! strives to provide a variety of food choices at our events with the space in our Food Court. As such, we do our best to assure that our food vendors are not offering duplicate menu items. Accordingly, we reserve the right to request certain items be not offered at accepted vendors' spaces should they repeat a previously accepted vendor's item(s).

Electric-enabled spaces are limited and require an additional fee – see next page. These spaces are allocated on a first-come-first-serve basis and are not available after the deadline.

**All food vendors are required to have \$1,000,000 liability insurance and supply Quakertown Alive! with a certificate naming Quakertown Alive! and the Borough of Quakertown as additional insured by May 1, 2025. If you have a food truck, you must have the appropriate certifications to serve in Bucks County.**

**\*\*\* All tents must be weighted down on all 4 sides.**

# QUAKERTOWN ALIVE! TERMS AND CONDITIONS

1. Quakertown Alive! reserves the right to accept or deny any vendor application.
2. The event committee will assign space location to the vendors. The committee can take special requests into consideration, but there is NO guarantee. Space assignments are final.
3. All vendors are required to remain open during the entire length of the event.
  - Arts Alive! – 10:00 AM – 4:00 PM
4. Vendors must adhere to the set-up times. NO early birds.
  - Arts Alive! set up begins at 7:30 AM. Vendors must be set up by 9:30 AM.
  - Food trucks may start entering at 7:30 AM. Food trucks must be parked by 9:00 AM.
5. Vendors may request an electric hookup. There is an additional \$15 cost for the electric hookup. Vendors MUST bring their own electrical cords.
  - There are a limited number of electric hookups available. Spaces are allocated on a first-come-first-served basis.
6. It is the sole responsibility of each accepted vendor to obtain any and all required, applicable, and appropriate state and local licenses/ permits needed. Each vendor also bears the sole responsibility for payment of all taxes pertaining to their operation.
7. All structures and sundries (tents, tables, chairs, trash cans, weights, etc.) are to be supplied by the vendor and are the responsibility of the vendor. All tents must be secured with weights to withstand changing weather conditions. QA! will have a Designated Safety Officer walking the event to check on tent weights.
8. Vendors agree to assume all liability for and agree to indemnify and hold harmless all organizations and persons sponsoring, managing or in any other way participating in the Arts Alive! Festival, including, but not limited to Quakertown Alive! and its personnel and Quakertown Borough from any seen or unseen injury, theft, or other loss to any person or property incurred by them or their representatives during travel to/ from, load in/ set up, event, and break down, claim, penalty, or lawsuit in any way arising from operation or involvement in the Arts Alive! festival.
9. If Quakertown Alive! cancels the event, the vendor will receive a refund of half the vendor fees upon request by either letter or email ([taylor@quakertownalive.com](mailto:taylor@quakertownalive.com)) within 30 days. Any fees that have not been requested for a refund will be considered a donation to Quakertown Alive!.
10. Quakertown Alive! events are family friendly. We reserve the right to decide if a questionable item/ service is allowable at our organization's event. All decisions are final.
11. Quakertown Alive! has permission to share images from the vendors' website and social media. Vendors may also have their and their goods' pictures taken at the event for use on the Quakertown Alive! website and social media.
12. Vendors must agree to abide by the above terms and conditions as well as supplied additional event guidelines. We expect our vendors to be kind and courteous to each other, attendees, and our volunteers. **Vendors must stay in their designated spot and are not permitted to walk the streets with products or samples.**
